



COOPERATION AGREEMENT

between

the University of Montenegro represented by the Rector, prof. dr Vladimir Božović

and

the University of Hacettepe represented by the Rector, prof. dr. Mehmet Cahit Güran

In order to promote international understanding and to enhance educational and research opportunities for their students and faculty the University of Hacettepe, Hacettepe Üniversitesi Rektörlüğü Sıhhiye/Ankara, Turkey and the University of Montenegro, Cetinjska 2, 81 000 Podgorica, Montenegro have agreed to cooperate within the framework of below mentioned principles.

Article 1.

Scientific and educational cooperation shall be undertaken in the areas of mutual interest. Such cooperation will be carried out on the basis of equal and mutual advantage.

Article 2.

The cooperation between the University of Hacettepe and the University of Montenegro may be implemented in the following ways:

- Facilitation of exchange of staff and students;
- Sharing good practice in university management, administration as well as research and teaching methods;
- 3) Organization of joint research activities/projects;
- 4) Organization of joint courses and/or curricula;
- 5) Organization of joint symposia, seminars and conferences
- 6) Facilitation of joint projects and programs based upon mutual interests

7) Exchange of publications, materials and information for scientific, scholarly, educational and information purposes.

Article 3.

The details of specific projects will be determined in addenda to the present Agreement.

Article 4.

Both parties agree that all the financial arrangements should be negotiated and will depend upon the availability of funds.

The Universities agree to seek financial support from national and international organizations for the activities and exchanges to be undertaken in the terms of this agreement.

Both universities commit themselves to aim at reciprocity on a quantitative and qualitative

Article 5.

The present Agreement is prepared in English in two copies. Both copies have the same legal

Article 6.

The Agreement is valid for 5 (five) years from the date of signing. The Agreement can be terminated by either Party subject to written notice to be received by the relevant partner no less than 3 (three) months before the expiration of Agreement; otherwise the duration of the Agreement shall be considered prolonged for 5 (five) more years. Each university shall reserve the right to terminate the protocol by giving a written notice to the other party three months.
